1. **Chairman's welcome address**

At the outset, Prof. (Dr) Raj Bahadur, Vice-Chancellor extended hearty welcome to the Members who came to attend 30th meeting of the Academic Council. He said that it is a great pleasure to see you all and seek the co-operation and assistance of members.

Hon'ble Vice-Chancellor said that the essence of University lies in academics and the University exists for academics but not for non-academics. The Chairman further apprised that drastic changes in the evaluation of University examinations have been made in the past years. The University, at present is on the state of full whoosh. A lot of changes have been initiated to bring the transparency and improve the existing examination system. The training programmes of all the colleges are closely monitored by the University.

The Academic Council is a very important body of the University. Therefore, it is his earnest desire to request you that all the affiliated and constituent colleges of the University, must make every effort to create an environment which raises the standard of education in terms of cultural and in term of academics. He emphasized that some induction and orientation programme for the students should also be introduced. The students are lacking in terms of academics and ethics. So, he expects from all affiliated institutions of this University that we must make efforts to inculcate the habit of ethics among the students and create an environment of academics so as to produce good medical professionals and make them to serve the humanity in a better way.

He also apprised the House that the scientific education implies that a student in a defined tenure of his curriculum should learn practical (skills) as well as theory to the extent that when he enters in the society for providing knowledge and skill, he/she is proved safe and efficient. Students must have optimum knowledge of the subject and skills. The teachers are for the purpose of evaluations of students at every level, with an objective to bring the substantial changes in the quality of medical students of BFUHS, so that when such students of our Colleges/University are placed in the society, he/she should be evaluated as compared to others.

All the members endorsed the views of worthy Vice-Chancellor regarding the betterment of the students and teachers and also for colleges. They further presumed that all the students will definitely adopt it as improvement in the academic standard as it is the pressing requirement of the hour.

Prof. (Dr) Raj Bahadur, Vice-Chancellor introduced Dr. Nirmal Ouesppachan, IAS newly Registrar of the University with the members of the Academic Council and on behalf of the Academic Council felicitated him for his appointment as Registrar of the Baba Farid University of Health Sciences, Faridkot. Dr. Nirmal Ouesppachan has qualified the IAS Exam in 2019. He also briefed about the past journey and family of Dr. Nirmal Ouesppachan.

Dr. Nirmal Ouesppachan thanked to the Vice-Chancellor & On behalf of University, he expressed that it was his proud privilege to welcome all the members for the meeting of Academic Council.

- 30.02 Considered and **RESOLVED:** To approve the Action Taken Report on the decisions taken by the Academic Council in its 29th meeting held on 20.12.2019 at 11:00 am in the Senate Hall, Baba Farid University of Health Sciences, Faridkot (**Pages 55 to 74 of Appendices of Agenda**).

While discussing the Action Taken Report of the 30th meeting of the Academic Council held on 20.12.2019 the following discussion & decision were taken:

Item No. 6 & 7 - DM (Critical Care Medicine) & DM (Clinical Haematology) courses

The Vice-Chancellor (Chairman) appreciates the step of DMC and CMC to start Super-specialty courses and desired that Govt. Medical Colleges should think about it.

Item No. 14 - Qualifications and experience of Nursing Faculty

The Vice-Chancellor (Chairman) apprised the House that revised Regulations & Curriculum for B.Sc. (Nursing) Program has been notified by the Indian Nursing Council, New Delhi. The University has decided to adopt the same and matter will be placed in the coming meeting of the Board of Studies in Nursing/Faculty of Nursing Sciences accordingly.

Item No. 16, 17, 18 & 20 - Post Basic Diploma in Nursing & NPCC

The Vice-Chancellor (Chairman) said that it is very useful courses and it will stimulate the students.

Item No. 21 to 24- Award of Ph.D. Degrees

The Vice-Chancellor (Chairman) apprised the House that degrees have been awarded to the candidates in anticipation of approval of the Academic Council in the Annual Convocation held on 13.08.2021. Sh. V.P. Singh Badnore, Hon'ble Government of Punjab and Chancellor of BFUHS, Faridkot had presided over the Convocation.

He further informed the House that entrance test for admission in Ph.D. in all the streams have been conducted on 07.07.2021. He further said that maximum students should be encouraged to pursue Ph.D. programme. The thesis work/research for PG course and Ph.D. should be relevant and related to the topic/subject. He exhorted the colleges to start research works.

Item No. 43- Proposed Govt. Medical College, Phase-VI, SAS Nagar (Mohali) for starting MBBS course

The Vice-Chancellor (Chairman) said that Govt. of Punjab is very keen to start Medical College at Mohali.

Item No. 45 to 61- Certificate Courses in affiliated Nursing Colleges

At this juncture, the Vice-Chancellor (Chairman) said that these certificate courses are meant for society and patient care. Some colleges consider these courses for money earning.

Some Hon'ble Members were of the view that the University should be more cognizant for these courses as the examinations are being conducted at the level of colleges. They further suggested that the University should also check the quality of examinations ~~from~~^{time} to time.

The Vice-Chancellor (Chairman) directed Dr. Deepak John Bhatti, Dean (Colleges Development), BFUHS, Faridkot to submit the list of colleges running certificate courses to him.

After some discussion it was **RESOLVED**: As under:

- i) That the University should be more vigilant to conduct examinations of these courses.
- ii) That the University should standardized more examinations system of these courses for quality improvement.

Item No. 62 to 64 -Disaffiliation of College/Discontinuation of Course

The Vice-Chancellor (Chairman) apprised the House that the colleges are inspected by the University from time to time to ensure that the education programme is being effectively and efficiently carried out and admission can be allowed. However, the colleges those are not fulfilling the norms and of sub standard should be closed/disaffiliate.

Item No. 65- Fellowship at Western University of Health Sciences, College of Podiatric Medicine (WesternU CPM)

The Vice-Chancellor (Chairman) desired that all the Principals of Medical Colleges should encourage their faculty members to join the Fellowships.




