2. The pay scales/emoluments for above said posts will be as per Punjab Govt. Notification for 7th CPC.
3. Pay as per Punjab Civil Service Rules (Volume-1, Part-I) under Clause No. 4.1(1) and Department of Personnel, Govt. of Punjab vide letter no. 7/204/2012-5FP1/66 dated 15/01/2015 and its amendments issued from time to time.
4. Knowledge of Punjabi: That candidate must have passed Punjabi upto Matriculation or its equivalent level at the time of applying.
5. Upper age limit: for above said posts, the maximum age is 37 years.  
Note: Relaxation in upper age limit as per Punjab Govt. Rules.

6. The qualification/experience of candidates should be prior/up to the last date of filling the applications and candidates should have to submit/upload the relevant certificates.
7. No TA/DA will be paid for the journeys performed for the Interview or written test/ counseling/document verification etc.
