Terms & Conditions

1. The University has right to increase or decrease the number of posts at any stage without citing any reason or not to fill any or all the posts, related to this Advertisement.
2. The pay scales/emoluments for above said posts will be as per Punjab Govt. Notification for 7th CPC.
3. Pay as per Punjab Civil Service Rules (Volume-1, Part-I) under Clause No. 4.1(1) and Department of Personnel, Govt. of Punjab vide letter no. 7/204/2012-5FP1/66 dated 15/01/2015 and its amendments issued from time to time.
4. Knowledge of Punjabi: That candidate must have passed Punjabi upto Matriculation or its equivalent level at the time of applying.
5. Upper age limit: for above said posts, the maximum age is 37 years.
Note: Relaxation in upper age limit as per Punjab Govt. Rules.
6. In case of posts of Pharmacy Officer as per Punjab Govt. (Deptt of Personnel), Letter/Notification No. 9/56/2020-5PP1/33 dated 12-01-2021, Upper age relaxation will be given to the candidate who is working / worked on contract basis on the same post in Baba Farid University of Health Sciences, Faridkot & its constituent Colleges/Institutes/Hospitals. Such age relaxation will be equivalent to the period he/she worked.
7. The qualification/experience of candidates should be prior/upto the last date of filling the applications and candidates should have to submit/upload the relevant certificates.
8. No TA/DA will be paid for the journeys performed for the Interview or written test/ counseling/document verification etc.
9. University has no any mechanism to check the certificates of candidates who are applying online. If, at any stage certificate of the candidate is found fictitious / bogus or ineligible, the candidature of the candidate will be cancelled and action will be taken according to law.
10. The certificates/diplomas/ degrees issued by non-recognized institutions will not be considered and the candidature of candidates will be declared ineligible.
11. Only those Government employees shall be eligible to get the appointment letters who are certified by the Head of the Department as not having any pending disciplinary proceedings or undergoing punishment under Punjab Civil Services (Punishment and Appeal) Rules, 1970, or any other material disqualification in terms of integrity and professional misconduct and necessary NOC should be obtained from the Head of the Department.
12. The applications received without fee or without legible copies of documents or apparently containing incomplete information and those received after the prescribed date & time will be summarily rejected.
13. Applicant must possess the requisite qualification by the last date of receipt of application.
14. Candidates already in service must route their application Through Proper Channel.
15. Whenever suitable candidate is not available, the terms & conditions may be relaxed on the directions of the higher authorities.
16. Candidates who will score 33% marks in written test will only be declared as eligible and the candidates who will score less then 33% marks in written test will be declared as ineligible.
